- 4 This Act may be cited as the "Student Empowerment

1	SEC. 2. 529 ACCOUNT FUNDING FOR HOMESCHOOL AND AD-
2	DITIONAL ELEMENTARY AND SECONDARY EX-
3	PENSES.
4	(a) In General.—Paragraph (7) of section 529(c),
5	as added by section 11032 of Public Law 115-97, is
6	amended to read as follows:
7	"(7) Treatment of elementary and sec-
8	ONDARY TUITION.—Any reference in this section to
9	the term 'qualified higher education expense' shall
10	include a reference to—
11	"(A) expenses for—
12	"(i) tuition,
13	"(ii) curriculum and curricular mate-
14	rials,
15	"(iii) books or other instructional ma-
16	terials,
17	"(iv) online educational materials,
18	"(v) tuition for tutoring or edu-
19	cational classes outside of the home, in-
20	cluding at a tutoring facility, but only if
21	the tutor or instructor is not related to the

23	"(I) is licensed as a teacher in
24	any State,
25	"(II) has taught at an eligible
26	educational institution, or

1	"(III) is a subject matter expert
2	in the relevant subject,
3	"(vi) fees for a nationally standard-
4	ized norm-referenced achievement test, an
5	advanced placement examination, or any
6	examinations related to college or univer-
7	sity admission,
8	"(vii) fees for dual enrollment in an
9	institution of higher education, and
10	"(viii) educational therapies for stu-
11	dents with disabilities provided by a li-
12	censed or accredited practitioner or pro-
13	vider, including occupational, behavioral,
14	physical, and speech-language therapies,
15	in connection with enrollment or attendance at,
