2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Preserve Charities and
5 Houses of Worship Act”.

1 **SEC. 2. REPEAL OF REQUIREMENT THAT UNRELATED BUSI-**
2 **NESS TAXABLE INCOME BE COMPUTED SEPA-**
3 **RATELY FOR EACH TRADE OR BUSINESS AC-**
4 **TIVITY.**

5 (a) IN GENERAL.—Section 512(a) of the Internal
6 Revenue Code of 1986 is amended by striking paragraph
7 (6).

8 (b) EFFECTIVE DATE.—The amendment made by
